# Election 2020 Pennsylvania Voter Data Analysis Summary

We analyzed the Pennsylvania State Voter data (Full Voter Export FVE, PAV) and mail-in ballot data (PAM), each published by the State of Pennsylvania, and each downloaded on three different dates (October 26, 2020, November 23, 2020, and August 2, 2021). We have concluded that a number of serious irregularities compel further investigations to ensure the public's confidence in election integrity and constitutional democracy.

Our key findings are the following: (we use "at least" in this study because the related data sets were not updated on time when they were downloaded and thus are under counted.)

- **485,284** voters were purged from the voter rolls between 11/23/2020 and 08/02/2021. Among those purged voters, at least **61,067** voted in the 2020 general election.
- 2 PHILADELPHIA and ALLEGHENY were the two top counties with most votes by purged voters, at **7,974** and **6,011 votes** respectively.
- 3 **107,001** voters were added to the voter rolls between 11/23/2020 and 08/02/2021. Among them at least **546 voters** voted in the 2020 general election.
- 4 Based on the data set downloaded on 11/23/2020, **2,260,952** inactive voters were on the voter rolls. Among them, **1,188,429** were born before 1988 and **798,248** of them **became active in 2020. 558, 314** of them voted in the 2020 general election.
- Among inactive voters of all ages, at least **8,480** voted in the 2020 general election and were purged after the general election in the time frame of 11/23/2020 to 08/02/2021. PHILADELPHIA was the top county with those voters.
- 6 Of the **558**, **314** inactive voters voted in the 2020 general election as indicated in (4), **2,223** voters were born before **1930**. Some of them were born as early as **1891**. PHILADELPHIA was the top county with those voters.
- 7 At least **12,761** mail-in ballots were missing at least one of required voter data such as date of birth (DOB), districts, application date, application approval date, and ballot send out date.
- **4,091** voters were purged between 10/26/2020 and 11/23/2020. Yet, at least **462** of them voted in the 2020 general election.
- 9 **6,314** voters were added between 10/26/2020 and 11/23/2020. At least **2,004** of them voted in the 2020 election. Some of these voters were born as early as 1920.
- 10 There were **488,582 voters** were purged from the voter roll between 10/26/2020~08/02/2021. Of these voters, **28,321** of them voted in the 2020 general election. Voters who also voted in local elections in May 2021 were not counted because their 2020 general election voting records were overwritten by the local election of 2021. Thus voted number is lower than that in (1)

- There were 312,453 addresses which were in the data set of 11/23/2020, but those addresses were not in the data set of 08/02/021. So they were purged after 11/23/2020. Among those purged addresses, there were 361,823 voters and 141,240 voted in 11/03/2020 general election. Unless those residential properties were demolished or uninhabited, how were those addresses purged?
- 12 There were 6k duplicate voters in data set of 11/23/2020. 2k voted in the general election.

### 1 Who we are

The analyst of this data is an unaffiliated, independent voter, with PhD and MS degrees in multiple science and engineering disciplines. This individual has had more than 30 years of experience working as a scientist and an engineer and would like to remain anonymous.

### 2 Data sources and methods

PAV "Full Voter Export" data was obtained from Pennsylvania Department of State – SURE Office. It was purchased and downloaded on October 26, 2020, November 23, 2020, and August 2, 2021, with personal funds at the following PA official web site:

https://www.pavoterservices.pa.gov/pages/purchasepafullvoterexport.aspx.

Data can be referred to in the dictionary of the document titled "Full Voter Export" at the above web site.

PAM data refers to mail-in ballot data, which only includes partial voters' data. It was downloaded free of charge on November 23, 2020, and August 2, 2021, at the following PA official web site (please refer to the web site for data format): <a href="https://data.pa.gov/widgets/mcba-yywm">https://data.pa.gov/widgets/mcba-yywm</a>.

The PAV and PAM data retrieved in November and August are presumably the updated data sets of those released and downloaded earlier. The dates of these data sets are referred to in YYYYMMDD format in this report.

We loaded the data into MySQL database and used SQL language, MS-Excel and LibreOffice-Calc, together with other Linux tools and shell scripts for data analysis. We can provide those program source codes upon request. PAV data was loaded into tables PAV20201026, PAV20201123 and PAV20210802. PAM data was loaded into tables PAM20201125 and PAM20210805.

#### 3 Results

## 3.1 Irregularities in mail-in ballots data (PAM)

The PAM data sets contain fields as shown below.

Figure 1 shows key findings that reflect irregularities in the two sets of PAM. For example, columns 9 and 10 show that over 10,000 ballots returned without mail-out date were recorded by the counties (column 9). Furthermore, counties accepted as valid ballots that were missing required voter data (column 10). Additionally, about 1,600 ballots returned had no records of the voter's date of birth

(column 8). Even if a voter was missing at least one required voter datum (listed in columns 6, 7, and 8), counties still sent out ballots (column 11).

The counties with the most problematic ballots contributing to the results in column 11 of **Figure 1** are identified in Figure 2.This preliminary analysis revealed that **10,428**<sup>1</sup> or **12,761**<sup>2</sup> mail-in ballots are in question.





Figure 3 Top 40 counties with most ballots with the same return and send out date.

Based on the data downloaded on 08/05/2021, 42,404 mail-in ballots had the same return date as the send out date. Figure 3 lists the number of ballots for the top 40 counties with the same return and send out dates.<sup>3</sup>

People who were monitoring the mail-in ballots data on PA government website also alleged that some of voters' ballots return dates were changed or modified after they were published and loaded into database. This data publishing website was closed to the public for several weeks after the 2020 general election when this allegation was raised. This allegation needs to be investigated.

Furthermore, based on the data downloaded on 08/02/2021, **186** ballots had a recorded return date occurring **before** the send-out date (Figure 4).

Finally, the top five counties with mail-in ballots received after 11/03/2020 are tabulated in Figure 5 The SCOTUS expressly directed that the late ballots be tallied separately.

## 3.2 Voter roll shifts after 2020 general election

We compared the voter rolls in the data sets downloaded on 11/23/2020 and on 08/02/2021.

**485,284** voters were purged<sup>4</sup> after the 2020 general election between the time frame of 11/23/2020 and 08/02/2021. Among them, at least **61,067** voters voted in the 2020 general election. Figure 6 shows the top ten counties with most votes by purged voters in the 2020 general election.

Additionally, **107,001** voters were added between 11/23/2020 and 08/02/2021. Among them, at least **546** voted in the 2020 general election.

*Figure 7* lists the number of inactive voters born before 1988 who voted in the 2020 general election. We define "an inactive voter" as a voter not having voted 30 times in any general, midterm or local elections. Figure 7 also includes the number of voters having unusual phone numbers with only 7 digits.


Figure 9 Top 10 counties of inactive voters who voted and later were purged between 11/23/2020 and 08/02/2021

For inactive voters of all ages there were at least **8,480** voters who were purged between 11/23/2020 and 08/02/2021 yet also voted in 2020 general elections. The top ten counties of those voters are listed in Figure 9




Figure 11 Sum of inactive voters who voted in the 2020 general election born up to a birth year

Figure 10 shows the number of inactive voters by birth year. Figure 11 shows the total number of inactive voters born up to a birth year. For example, as graphed in Figure 11, 558,3145 and 332,2986 inactive voters born before 1988 voted in the 2020 general election. There appear to be many extremely aged voters with birth years before 1920.

Even if a portion of those voters were subject to voting irregularities, the number of votes may still have influenced the election results. Those past inactive voters who were activated, "voted" in the 2020 election, and then purged after the election should be scrutinized.

## 3.3 Voter roll shifts around the time of 2020 general election

A PAV data set was obtained and downloaded on Oct. 26, 2020, with data recorded before the election. A comparison of this data set with one downloaded on Nov. 23, 2020, revealed the voter roll shifts before and immediately after the election. We note that voter registration **deadline** for the 2020 general election was **Oct. 19, 2020**, and that the data downloaded on Oct. 26, 2020, and Nov. 23, 2020, may not have been completely up to date.

We found **4,091** voters were in the voter rolls of 10/26/2020 but not in those of 11/23/2020. This means that at least **4,091** voters were purged around the time of the 11/03/2020 election. Out of those purged, **at least 462** persons voted in the 2020 election. If the data downloaded on the above two dates indeed were not up to date, then the actual numbers would even be higher. Those **462** voters included some born as early as **1916**.

We also found that at least **6,314** voters were added between 10/26/2020 and 11/23/2020. Among them, at **least 2,004** voters voted in the 2020 election. These added voters had birth years as early as **1897**. The top ten counties with voter's registration dates past the deadline is listed in Figure 12. These "voters" who voted and were then purged right afterwards should be examined carefully.

#### 3.4 Voter roll shifts between 10/26/2020 and 08/02/2021

**488,684** voters were in the voter rolls of 10/26/2020 but not in those of 08/02/2021. The shift means a purge of **488,684** voters around nine months after the 11/03/2020 general election. Of those purged, **at least 28,327** voted in the 2020 general election, including those with birth years as early as **1823**.




Figure 13 Voters Purged from Voter Roll of 10/26/2020 between 10/26/2020~08/02/2021

Figure 13 shows those purged voters by each birth year from the voter roll downloaded on 10/26/2020. Those voters were not in the voter roll downloaded on 08/02/2021. Therefore, these voters were purged somewhere between 10/26/2020 and 08/02/2021. The total count of purged voters is **488,582**. A large amount of those purged voters voted in the 2020 general election, at least 28,321. Some of these voters were born before 1890.

**Figure 14** shows the top ten counties with most votes by purged voters as of data from 10/26/2020.

There were 312,453 addresses which were in the data set of 11/23/2020, but those addresses were not in the data set of 08/02/2021. So they were purged after 11/23/2020. Among those purged addresses, there were 361,823 voters and 141,240 voted in the 11/03/2020 general election. PHILADELPHIA had 22,293, ALLEGHENY had 15,433 and MONTGOMERY had 10,676.

#### 3.6 Identical Voters

Define those properties (Last\_Name,First\_Name,Middle\_Name,Suffix,Gender,DOB) as the voter properties. When they are the same we call them identical voters: (such as twin, triplet, ... etc). There was possibility that there were real different voters among those identical voters. For all three data sets, the numbers as shown below. They need to be visited in person to make sure they were not registered and voted by others or victims of identity theft.
